# **Membership** Your Key To The NASTD Community

**NASTD** offers four membership categories: state, state associate, corporate affiliate and small business affiliate. Each membership is held in the name of the dues paying entity and membership benefits flow to designated individuals working for the entity. Each entity is asked to designate a primary member contact.

# **State Membership**

State membership is open to full-time employees from the state agencies or departments with primary responsibility for provisioning and managing technology resources. Annual membership dues - \$4,500

# Associate Membership

Associate membership is open to any governmental department, agency, board or public institution with responsibility for, or an executive interest in, technology. Annual membership dues - \$1,000

## **Corporate Membership**

Corporate Affiliate membership is open to private sector businesses with more than 15 full-time equivalent employees or those businesses with revenues exceeding \$1 million. Annual membership dues - \$4,500

#### Small Business Affiliate Membership

Small Business Affiliate membership is open to private sector businesses with 15 or fewer fulltime equivalent employees or those businesses with revenues of \$1 million or less. Annual membership dues - \$2,000

#### Who We Are NASTD represents information technology professionals from the 50 states, divided into four regions, and the private sector. State members provide and manage state government IT services and facilities for state agencies and other public

and manage state government II services and facilities for state agencies and other public entities. These members also play a strategic role in planning and shaping state government technology infrastructures and policies. Corporate members provide IT services and equipment to state government.
